


Educational Training Information Provided



CEO WRITTEN REPORT December 2016

Accelerate scientific advancements by funding research, driving the development of tools that support basic, translational and clinical research, and advocating for research funding by partnering with government and industry sponsors and other patient organization.

The CSO participated in the TSCRP Programmatic Panel vision setting meeting for FY2017 on December 1.

The CEO, CSO, VPCS, SDDR, MRGA, and DCPTCL attended the **American Epilepsy Society** (AES) annual meeting in Houston, December 2 – 6. Events and meetings included:

- Epilepsy Leadership Council meeting of government and non-profit organizations involved in epilepsy care, training, and research on December 2.
- TS Alliance Reception the evening of December 2 was attended by nearly 80 industry, non-profit, and academic partners and featured a call to action for IS Awareness Week, presentation of the IS HOPE Award to Ellen Wehrman, on overview of the PREVeNT Trial by Martina Bebin, information on CBD data and the ongoing trial in TSC by Elizabeth Thiele, and data from the EXIST-3 trial by Darcy Krueger.
- Partnering and/or scientific meetings with industry partners UCB, GW Pharma, Novartis, Upsher-Smith, Mallinckrodt, LivaNova, Sage Therapeutics, Zogenix, and Lundbeck. The CEO and CSO spoke briefly at the Upsher-Smith reception and attended the UCB reception, and the CEO and SDDR attended the Lundbeck reception.
- The TSC Clinic Directors Meeting on December 3 had 28 attendees (including 5 TS Alliance staff) participating in useful discussions on sharing best practices.
- Infantile Spasms Advocacy Forum on December 4 provided the opportunity to meet with current IS Week partners and begin to plan for 2017 activities and expansion into a year-round Action Network.
- The Infantile Spasms Awareness Pavilion on December 5 welcomed more than 100 visitors and featured a poster and presentation by Dr. Martina Bebin on the PREVeNT trial.
- TSC research was featured throughout AES, most visibly in the Presidential Symposium, a session on TSC (understanding and modifying epileptogenesis), and a TSC Special Interest Group.
- The CSO and DCPTCL met with UCLA neurosurgeons, Drs. Gary Mathern and Aria Fallah, and TSC Clinic Director, Dr. Joyce Wu, in Houston on December 3 to discuss the TS Alliance TSC Biosample Repository Project, Dr. Mathern's UCLA Rare Brain Disease Tissue Bank and possible ways to collaborate.

The CEO, CSO, and MRGA had annual visits with senior staff of **NCATS**, **NIDDK**, **and NIAMS** during the week of December 12.

On December 14, the staff from **The LAM Foundation** visited the TS Alliance office to make decisions on a number of aspects regarding the 2017 International Research Conference on TSC and LAM. As a result,

the room block was increased and additional meeting space was obtained from the hotel to accommodate more educational sessions for individuals and families affected by TSC and/or LAM.

Identify more individuals impacted by TSC and engage them through improved clinical and support services.

There was a decrease in the number **constituent contacts** in December from 337 in the previous month to 188 in December. The percentage of education-related calls decreased from 53% to 51% from the previous month. Out of the 188 contacts, 17% were from adults with TSC (this does not include the support numbers provided by the ARCs). There was a total of 25 face to face supports to families/individuals with TSC (Face to Face numbers includes ARCs, Clinic Ambassadors (on site), Community Alliances, and Vice President of Outreach). There were also 59 one-on-one support contacts provided by Community Alliances.

CDs and **healthcare e-packets** were given to 11 doctors in need of information on TSC diagnosis, treatment, and management in TX, CA, DE, CA, NY, VA, MD, NC, SC, DC, WV.

We added 11 new individuals to our constituent database through the **website popup** in December, of which 55% were parents, 16% were individuals with TSC, 8% relatives, 8% physicians and the remainder sibling, grandparent and other.

In December, the overall **website hits** decreased by 477,447 (38%) hits from November. **Total downloads also** decreased by 51% from November. Some of our stats are only through December 14 when the new site was launched. Since the new site is on a different platform, we are working with the web vendor on how to meaningfully capture analytics. The summary report can be found below.

Broaden and strengthen the base of financial support for TSC research, TS Alliance and TS Alliance Endowment Fund from both private and public sources.

Through December 31, 2016, **total revenue** for the year is \$5,240,880 compared to budget of \$4,418,335, creating a positive variance of \$822,545. The positive variance is in large part due to the \$1.5 million pledge from the Engles Family Foundation and the Lundbeck Impact Fund grant (\$210,000 of the \$282,500 recognized in 2016), which gives us a positive variance for grants of \$1,354,238 for the year. This variance, along with a \$211,005 positive variance for contract revenue is partially offset by a few factors: (a) major donor contributions came in (\$320,462) under budget since the Engles' pledge came in as a grant rather than the \$250,000 that was budgeted for the Family as a major donation; (b) Net Special Events revenue came in (\$148,476) below budget primarily due to Walk and major event shortfalls; and (c) electing to do without any contribution from the Endowment Fund this year created a (\$206,000) negative variance.

Total expenses for the year ending December 31, 2016 are \$4,923,005 which exceeds budgeted expenses by \$354,725. The main reason for the higher expenses is that we aimed to reach at least 75% program spending for the full year, and prioritized spending in excess of budget levels on research and global outreach grants at year end to reach that goal. Grant spending exceeded budget by \$388,391, which was partially offset by the Preclinical Consortium studies coming in \$139,239 under budget. Overall, spending on research and global outreach grants/contracts was \$1,972,347 for the year, which was \$239,130 over budget. Spending on travel also exceeded budget by \$80,783. We were able to increase the portion of our spending on programs to 76.25% for the year. The Change in Net Assets for 2016 is a positive \$316,750 vs. a budgeted deficit of (\$149,946).

The **TS Alliance Endowment Fund** has \$42,684 in donations in 2016 compared to \$34,656 for 2015. The Fund is showing a \$530,708 positive change in net assets for the year, due to the \$525,868 increase in value of its investments, not needing to pay out any of \$206,000 Endowment contribution to the TS Alliance that was budgeted for 2016, and other expenses being kept to a minimum.

The **Twelve Month Trailing Totals Chart** demonstrates a decrease in revenues and increase in expenses. The decrease in revenue can be accounted for by the decrease in major gifts, in part by a timing issue since some of these gifts were received in January. The increase in expenses due to the additional grants funded at year end in research and global alliances, which allowed us to reach target program expense ratios.

As of December 31, **Major Donor** gifts accounted for \$785,533 versus a budget of \$1,106,495. Some significant budgeted contributions impacting this discrepancy are: \$250,000 gift budgeted to be received by Gregg Engles that was increased to \$1.5 million but was accounted for in Grants; \$50,000 budgeted and not received from Chris and Joy Dinsdale and \$50,00 budgeted to be received by Board Prospects.

Major Donor and Corporate visits were made in December with:

As a result, UCB approved a \$15,000 grant at year end to support the Volunteer Leadership Training.
- **Greenwich Biosciences**, December 3, the CEO and SDDR met with Michelle Welborn, Ryan Bovia, Alice Mead, Jennifer Triemstra, Al Marshall and Julian Gangolli to discuss sponsorship of DC Sound Bites, Comedy for a Cure, Step Forward to Cure TSC Walks, Regional Conferences and Transition Workshops, Research Conference, MN Sounds Bites and the 2018 World TSC Conference. Michelle

requested we send all requests by the end of the year which we did. We also discussed how we can help with the rescheduling process for cannabinoids and learned that in the US, GW will now be known as Greenwich Biosciences due the existence of an American company with the GW name.

- Novartis, December 3, the CEO and SDDR met with Jane Vesotsky to discuss transition of care, TSC Global Awareness Day and treatment access.
- **Brain Sentinel,** December 3, CEO and SDDR met with Tracy Blitz, Jeff Jung and Mike Girouard to discuss opportunities for partnership including International Research Conference, Regional Conferences and Transition Workshops.
- Child Neurology Foundation, December 3, the CEO and SDDR had dinner with Executive Director, Amy Miller.
- Mallinckrodt, December 4, the CEO and SDDR met with Cathy Jackson, Molli Salzman, Keith Fry and Sylvia to discuss sponsorship of DC Sound Bites / Advocacy Training, Comedy for a Cure, Step Forward to Cure TSC Walks, Regional Conferences, IS Awareness and the 2018 World TSC Conference.
- LivaNova, December 4, the CEO and SDDR met with Jennifer Lively, Kim Cooper and Victoria Driscoll (Nate Minnich joined briefly at the end) to discuss sponsorship of Step Forward to Cure TSC Walks, Regional Conferences and Transition Workshops, Research Conference and the 2018 World TSC Conference.
- Upsher-Smith, December 4, the CEO and SDDR me with Dave Stefanoni to discuss sponsorship of DC Sound Bites, Comedy for a Cure, Step Forward to Cure TSC Walks, Regional Conferences and Transition Workshops, Research Conference and the 2018 World TSC Conference. Dave let us know that their budgets for advocacy are being cut by 30% but that he has funds in mind to direct toward the TS Alliance.
- Lundbeck, December 4, the CEO and SDDR met with Deena Andreola to talk about IS Awareness.
- CVS, December 19, the CEO, CSO, Vice President of Outreach and SDDR met with Calvin Wasdyke, Ross Luke, Andrew Glover, Glen Howell, Joel Helle and Faith Weiner to discuss access to treatment and sponsorship opportunities, particularly Step Forward to Cure TSC walks and Comedy for a Cure.

Grants as of December 31 totaled \$2,194,674 versus a budgeted \$842,100. Included in grants received in December:

Honorariums & Memorials as of December 31 totaled \$68,707 versus a budgeted \$103,200. Appeals as of December 31 totaled \$97,312 versus a budgeted \$112,500. Federated Funding as of November 30 totaled \$36,904 versus a budgeted \$60,000.

Special Events as of December 31, net totaled \$1,363,223 versus a budgeted \$1,526,890.

Facilitate more interaction among the national and international TSC community.

In December, there was a total of 241 **volunteer hours** and 46 **volunteer participants**. There were 145 oneon-one support contacts between the Community Outreach Manager and the TSC community. A total of 133 people attended TS Alliance events in Arkansas, Kentucky, Texas, Illinois, Ohio and Georgia.

Throughout December, the **Adult Regional Coordinators (ARCs)** supported 557 adults with TSC through phone, e-mail, Facebook, and face to face. The ARCs had a conference call meeting to discuss and decide the topics and speakers for the Jan, Feb, March Adult Topic Calls.

There were 71 parents/caregivers supported through the **Dependent Adult Transitional Resource Coordinators (DATRCs)** program in December. A new DATRC was added in AZ and Puerto Rico.

We officially added the TS Alliance of Mexico and the TS Alliance ASEAN Foundation (TSAAF) in Thailand as Global Alliances, with signed Global Affiliate and International Grant agreements for seed funding. We will work with both organizations on when to make public announcements about these partnerships in the upcoming year. Mexico is now a legal, registered entity, and Thailand will begin the process of establishing themselves as a legal entity now that they have some funding in place. Nok and Carl Brenden from TSAAF and Ary Agami from the TS Alliance of Mexico are the founders of our newest global partners.

Our membership on **Inspire** grew by 67 to 4,411 from 103 countries. There were 3 journal entries and 510 replies in December. There were 24 new discussions and 82 replies. The top three posts were:

- "Diet for TS" posted from a parent of a newly diagnosed son looking at diets, asking others for their experience and good books detailing different types of diets.
- "Surgery?" posted from a mother of a 10-week-old daughter who has had sub-clinical seizures since birth, considering brain surgery and asking for others experience.
- "14 weeks Pregnant with Tuberous Sclerosis" from a 32-year-old woman with TSC who found out she was pregnant with a girl carrying the same TSC1 mutation and looking for support if others had been in that situation.

Increase diversity of Board membership and enhance staff skill sets to ensure execution of the strategic plan and to maintain recognition of TSC as a linchpin disorder.

The TS Alliance participated in **Infantile Spasms Awareness Week** activities December 1-7, specifically leading communications and media efforts. Working with McCabe Messaging a communications toolkit was developed and circulated to 15 partners. The TS Alliance conducted a **media tou**r with 16 Radio and TV interviews with 30 placements with 6,083,651 total audience. The CEO, Board Member Dr. Martina Bebin and Hope Award Winner Ellen Wehrman participated.

The new **TS Alliance website** launched on December 14 after a year of planning, preparation and work by the entire staff team and led by the Vice President Communications Strategy (VPCS). In addition, the VPCS worked with our vendor Teramark on new email signatures, letterhead/envelope designs, and eBlast email templates for Luminate and NetCommunity

On December 8, David Coit, **prospective board member**, visited the TS Alliance office. Incoming Board Chair Tim Dills and all staff participated in a welcome meeting followed by more detailed presentations by the CEO, CSO and CFO and lunch with Tim Dills and the CEO.

The CEO, SDDR and SMSE conducted nine 1-hour interviews for the **Director of Special Events and Corporate Partnerships.** As a result of interviews by the staff team and search committee, April Cooper was offered the position and began January 3. Additionally, Gail Saunders was promoted **to Associate Director**, **National Walks and Community Campaigns** and Shelly Meitzler signed a contract to support Step Forward to Cure TSC walks as the **National Walk Coordinator**.

With the help of all staff, the CSO interviewed several individuals for the new **Science Project Coordinator** position and offered the job to Calvin Ho, who agreed to start in January. This position will increase the impact and visibility of the TS Alliance's research programs.
